## Director of Tennis Report (Aurelie Udall):

GLTA season is at a mid-season point – all going well. Additional fee will be received from Chris to fund court monitor (David will follow up on status), no end of season tourney scheduled at UCRC.

USTA tournaments are currently not scheduled, waiting on dates from USTA, appears that October will be the likely date (Aurelie will follow up)
